

Registration Agreement 2018-19

General Registration Information

Classes start **September 5th** and end **June 10th**. There is a \$20 non-refundable registration fee each year per family. This covers registering for our dance school and preschool for the year!

Military Discount: Show your Military ID and get the registration fee waived.

Enrollment is for the entire year. Please refer to the **withdrawal policy** if you plan to leave class before June 10th. We enroll new students until **January 19th** for all classes participating in the recital. Non-performing classes take new students year around. The Director reserves the right to change teaching staff if necessary.

Early bird discount: Register and pay before June 30, 2018 and get registration fee waived.

Boys in ballet! Any families registered at the Dance Center of Spokane are invited to put their sons in ballet on scholarship.

Student and Parent Responsibilities:

Attendance:

All students are expected to arrive on time for class in the proper attire and their hair up in the appropriate style. If the student is too young to handle this on his or her own, we ask that the parent help with this responsibility.

If a student is ill he or she is expected to stay home. If a student is injured and would like to continue in the class the student should come observe class until she/he can dance again. If a student is absent there will be no adjustment of tuition. Make-ups are offered as a courtesy. Please arrange make-ups through the office.

Parents must be ready to pick up their children as soon as possible after class has adjourned. The Dance Center Staff is not liable or responsible for watching your children. **Please do not leave a sibling or friend in the waiting room while the other sibling dances unless you plan to stay and observe as well.**

Classroom Limits:

Classroom limit is 12 dancers for 45 minute classes and 15 dancers for one hour or more. Exceptions are hiphop (15 for 45 minutes classes, 20 for one hour classes) and advanced classes if more than the limit is at that level.

Withdrawals :

Please inform the office, not the teacher, of any classes dropped or added. Two weeks notice is needed for any withdrawals. Please remember there are no refunds for both registration fees and recital fees. After a costume has been ordered and paid for you will not receive a refund. If costume is purchased you may pick up costume at the end of year after recital.

Lost and Found:

Please remember to check the Lost and Found box frequently. We donate items from the lost and found box to Goodwill during Winter Break, Spring Break, and at the end of the year. The Dance Center of Spokane is not responsible for lost or stolen items. Please leave all valuables at home.

Recital Information

Recital Policy: A recital fee for either one or both recitals is due on November 1st. \$50 for one day or \$80 for both days. The recitals will then have free admission. The rehearsals and recitals will be held in lieu of the regularly scheduled classes on June 3-6th at the Bing Crosby Theater. Non performing classes, designated with a ^, do not perform in the recital so no fee is collected.

Costumes: A costume deposit of \$35 per class is due on November 1st with the remainder to be paid by January 12th. All Jazz, Tap, Lyrical, and Hiphop classes need a costume. Ballet is usually one costume per level. There are no refunds on costumes once they have been ordered. Average price of a costume is \$75 for recital dances. Non-Performing classes do not need a costume.

Holidays:

There will be no classes during these times:

The studio will be closed if District 81 cancels due to snow or in the event of an unforeseen natural disaster. If this occurs, there are no refunds or make-ups. Please note though that we are open on some of District 81's holidays.

Tuition

There are five options to pay your tuition. Each option is priced per family. Please understand, regardless of the payment option you choose, your payment(s) are based on 36 weeks of instruction which occur within a 40 week period. While we periodically break throughout the year, payment for tuition is expected on a regular basis.

Tuition can be paid Annually, every 12 weeks or every 4 weeks. If you choose to Autopay you will get a \$5.00 discount per class. There is a non refundable \$20 registration fee per family if you register after June 30th, 2018. Registration fee is waived with a Military ID.

We also offer unlimited classes for any individual who pays for 7 classes regardless of his or her option of payment plan. This offer is per student not per family. Please note: Ballet Repertoire and Saturday All-styles does not count as a class for the unlimited class offer.

Billing Options. (Please Select One)

There is a two tiered payment system. If you choose to pay automatically you will get a \$5.00 discount per class! If you choose to be billed all bills will be sent monthly by e-mail only!

Option A (Annually) Must register by Sept 5th

Tuition may be paid yearly. You will receive a 5% discount off of the combined quarterly auto pay sum, due upon registration.

Yearly fees with discount added are:

Option B (12 weeks) will prorate if necessary

Tuition will be paid upon registration, then by the first of December and March, respectively. There will be a \$10.00 late fee charged if you do not pay within the month due.

Option C (4 weeks) Must register by Dec 8th

Tuition is 9 equal payments. The first payment will be paid upon registration and then on the 1st of October through the 1st of May. There will be a \$10.00 late fee charged if you do not pay within the month due.

Late Fees:

A late fee of \$10 will be applied for any debt 30 days past due. Further, a new \$10 late fee will be charged each month any debt remains outstanding.

Competition

A costume deposit of \$50.00 per dance will be collected on October 1st. The costume balance must be paid in full by November 2nd. The balance will be given to you as late as one week in advance. Expect an average of \$85 per costume.

We will calculate the competition fees for each respective student/family and make the totals along with the due dates available to you no later than Dec 31st.

***Competition Late Fees ***

If you have not paid us by the day we have to pay the entry fee for your child you will be assessed a \$25 late fee immediately. Please plan accordingly!
